The City Council has approved a bill to name a Bronx street in honor of Tim Hendrick, a Korean War Veteran.

The action on December 21 followed by a day the bill's passage in the Council's Committee on Parks, Recreation and Cultural Affairs, whose chairman is Councilman Walter Ward. Mayor Beame is expected to sign it into law shortly.

The measure was introduced by Bronx Council members Stanley Simon and Aileen B. Ryan. It would rename one block of West 236th Street, between Broadway and the Conrail right of way, as Tim Hendrick Place.

Mr. Hendrick, an Army veteran who died at 42 in 1973, started the annual block party honoring veterans in the Kingsbridge-Marble Hill-Riverdale area. Since 1967, proceeds from the party have gone to the Chaplain's Fund of the Kingsbridge Veterans Administration Hospital.

#### TIM HENDRICK: A RESUME

Tim Hendrick was a quality product of Kingsbridge. He lived here, worked here, and here in this community he served his neighbors for all of his adult life.

A product of local elementary and high schools, Tim also matriculated at the school of "hard knocks". In his early 'teens, he hawked peanuts and popcorn at the Old Yankee Stadium and Polo Grounds, and in doing so, he learned the value of a dollar. This experience was to stand him in very good stead later on in life, for he started his own automotive repair shop in "Gasoline Alley", on west 230th Street. His general attitude and the excellence of his work endeared him to many, many people in the surrounding community.

A good part of Tim's life was centered not only on his own two youngsters, but on the kids of the Kingsbridge area in general. Year after year, Tim could be seen on Saturdays tutoring the many hopeful Little Leaguers in the fundamentals of baseball. Van Cortlandt Park was also the evening scene, with Timmy again playing a similar role with even younger boys, eager to learn. Bunting drills, shagging flies, throwing and catching on the dead run were all a part of his devoted work with these kids.

It was Tim Hendrick who first concieved the idea of having a Block Party in Kingsbridge. Back in the Winter of 1967, Tim held an impromptu meeting over a well-filled penny jar in a local business establishment. From those early beginnings, and with Tim spearheading the early plans and developing them, a committee was formed in the late Winter of that year. It's goal was to sponsor a Block Party in honor of All Veterans on West 236th Street.

On a gloriously cool and sunshiny day in mid-September of 1968, the committee played host to well over 900 of its neighbors in the Kingsbridge-Marble Hill-Riverdale sections of our community. The feasting and merriment continued from mid-day to the late afternoon hours, and in the gathering dusk a very happy throng filed contentedly out of West 236th Street.

Tim Hendrick was to play an active role in the succeeding yearly affairs - all of which have benefitted the Chaplain's Fund up at the Kingsbridge Veterans Hospital - until he met a tragic, untimely death in the Fall of 1973.

It is a signal honor for the West 236th Street Block Party Committee to have been associated with this fine man. And in this Bicentennial year, we would very much like to perpetuate Tim's memory in a most significant way.

With the Wm. E. Irwin Post #774 of the American Legion, and the Veterans of Foreign Wars supporting us as co-sponsors this year, we are assured of success on our 1976 gala to be

.held on Saturday, July 3rd.

And thus united in a righteous cause, we are striving to have that intersection of West 236th Street and West Putnam Avenue re-named "TIM HENDRICK PLACE".
