Report of the Committee on Parks, Recreation and Cultural Affairs in Favor of Approving and Adopting as Amended a Local Law to Amend the Administrative Code of the City of New York, in Relation to a Street Name, Euclid Avenue-Father John Krieg Place, Borough of Brooklyn.

(For text, see Reports of Standing Committees printed in the Minutes of the Stated Meeting of March 30, 1982.)

On motion of the Vice-Chairman (Council Member Cuite), and adopted, the foregoing matter was coupled as a General Ofder for the day. (See ROLL CALL ON GENERAL ORDERS FOR THE DAY.)

The next public hearing is on Introductory Number 1161-A, sponsored by Council Member Michael Long and co-sponsored by Council Members Ward, Codd and Foster. This bill names a portion of Euclid Avenue in Brooklyn as Euclid Avenue-Father John Krieg Place.

Father John Krieg was born in September, 1901, in Brooklyn, and attended St. Michael's Parochial School. After he decided to become a priest, he attended Cathedral College in Brooklyn, graduating in 1924. Father Krieg was ordained in 1930, and was assigned to St. Cecelia Parish in the Brooklyn section of Greenpoint. He had a unique talent for persuasion and organizing which enabled him to successfully raise funds for construction of a parochial school.

In 1959, Father Krieg was named as pastor of Blessed Sacrament. While attending to his own parish, he also served as chairman of one of the Diocesan districts, raising over \$300,000 for construction of the Madonna Residence and five new high schools in the diocese.

It is reported that perhaps his greatest accomplishment was the establishment of the Cypress Hill-Fulton Street Senior Citizens Center in 1972.

Although he has become incapacitated, Father Krieg's hard work and dedication to his church and community will be acknowledged through the naming of this street in his honor.

Father Krieg had his first experience of running a parish, at the Church of the Nativity when he was named administrator for the sick and incapacitated Monsignor Belford. Within a short time, he had greatly improved the physical structure of the Church of the Nativity and expanded the size of its school.

Finally, on June 24th, 1959, Father Krieg was named as pastor of Blessed Sacrament. While efficiently running his own parish, Bishop McEntegart appointed him as Chairman for one of the Diocesan districts. Assigned the goal of raising \$150,000, his district raised over \$300,000 for the construction of the Madonna Residence and five new High Schools in the Diocese.

At Blessed Sacrament, he added new classrooms to the school and completely repaired and refinished the Church, rectory and convent. His greatest project was the establishment of the Cypress Hill-Fulton Street Senior Citizens' Center in 1972.

The Senior Citizens' Center was officially dedicated on June 22, 1973. His Excellency, Bishop Mugavero and numerous members of the clergy as well as Mayor Lindsay and other dignataries were present. The center serves hundreds of senior citizens from the area who are extremely grateful to Father Krieg for making this great dream a reality.

Father Krieg is presently being cared for at the Ozanam Hall of Queens Nursing Home in Bayside. Father Krieg had suffered a severe stroke.

As a result of a request from the City Planning Commission, the bill will be corrected to read as follows: Euclid Avenue/Father John Krieg Place, instead of Father John Krieg Place—Euclid Avenue.

John Anthony Krieg was born September 5th, 1901 in Brooklyn of good, hardworking, catholic parents. He was the seventh of ten children. From the outstanding example and teaching of God-loving and God-serving parents four of nine surviving children entered the service of God-two as priests and two nuns. Besides Father Krieg, a brother, Joseph, is an ordained Capuchin priest with the religious name of Father Pancratius, presently stationed at St. Michael's, here in East New York. Two of the sisters became Sisters of St. Dominic of the Brooklyn branch of that Order with its Mother House at Amityville. Sister Marie Celine has since passed this vale of tears into the arms of her Saviour and Sister Adalbert, Dean of the School of Business Administration at Catholic University of Puerto Rico is now retired.

Father Krieg attended St. Michael's Parochial School. After some secondary education temporarily discontinued his studies to go to work. Deciding to study for the Diocesan priesthood he returned to school and was graduated from Cathedral College, Brooklyn in June 1924. After six years of study at St. John's University, he was ordained to the Holy Priesthood by His Excellency, Archbishop Thomas E. Molloy, on April 6th, 1930.

Immediately after ordination he was assigned to St. Cecilia's Church, Greenpoint, where he remained for more than three years. The next nine years he spent at St. Catherine of Genoa, Brooklyn. He went to Nativity Church, Brooklyn in June 1942. Father Krieg has always been a hardworking and efficient priest. God blessed him with special talents, and most notably with a talent for organization, administration and priestly zeal. He has an unique talent for administering to the material and financial needs of a parish.

While a curate of St. Cecilia's Church he conceived the idea of installing a public address system. Having obtained the permission of his pastor, drawing on his electrical knowledge and experience, he built this system and installed it himself. It is believed that this was one of the first public address systems to be installed in any church of the Diocese.

At the Church of St. Catherine of Genoa he was of invaluable assistance to the pastor, at present an Auxiliary Bishop of the Diocese of Brooklyn and Pastor Emeritus of Our Lady of Angels Church, the Most Reverend John A. Boardman. He was particularly successful in running parochial affairs, including a giant bingo which raised funds which later on made possible the payment of the debt on the building of the parochial school which was built by Monsignor Gorman. When he went to the Church of the Nativity he soon became a staunch support for

the aged and sick Monsignor Belford whose name, personality and accomplishments are almost inseparable from the name and certainly from the history of the parish of the Nativity. When illness finally incapacitated Monsignor Belford, Father Krieg was named administrator of the parish on December 17th, 1951.

Father Krieg then proceeded to put the entire plant in beautiful shape through construction where needed, renovation and decoration. with his interest in the parochial school and Catholic education of children Father Krieg generously opened the doors of Nativity school to children from other parishes. This farsighted and generous use of the facilities of Nativity parish has done untold and unknown good.

On June 24th, 1959, Father Krieg, a zealous and sterling priest, an organizer par excellence and an administrator of rare ability, arrived at Blessed Sacrament to take over as pastor. He began to carry on and in many ways surpass the excellent pastorates of his predecessors.

The parishioners were soon to see his ability and talent for in 1960 Bishop McEntegart Bishop of Brooklyn began his drive for funds for Madonna Residence and five new High Schools, and aware of Father Krieg's administration ability appointed him Chairman of one of the Diocesan Districts, comprising ten parishes. Blessed Sacrament was one of these parishes and a goal of over \$150,000.00 was set for it. Thru his organizing ability and administration talent, Father Krieg, showed the way for the goal to be not only reached, but in fact doubled a total of over \$300,000.00 was realized by Blessed Sacrament parish. All the other parishes in Father Kriegs' District surpassed their goals.

Even with this tremendous task under way he set about putting his own parish plant in order. To date he has added four classrooms to the school, made permanent ones of two temporary classrooms and refurbished and decorated the entire school. The entire insides of the school had its face lifted by a paint job. The same was done for the rectory and convent. In 1965, in preparation for the 75th Jubilee, he had the entire church completely repaired and refinished, especially by a beautiful paint job on the inside of the church, which brightens it and enhances its true beauty. He also added a bronze rail to the sancturay. In this same year he had built and completely furnished a beautiful and much needed Community Room for the Sisters, in the basement of the convent.

Being a far-sighted man and looking to the future he purchased a tract of land and house at 170 Euclid Avenue. He renovated and modernized the house, in which two of our families now live and also

Had built a three car brick garage on the rear of this same property. In 1968 the opportunity arose where he purchased another house at 149 Chestnut Street. In this house on the first floor he converted into a beautiful Library for the children of Blessed Sacrament School. To the entire real estate of Blessed Sacrament he is constantly improving and preserving. The lawns, landscaping and buildings are in such beautiful condition that our parish property is the garden spot of Cypress Hills and one of the most outstanding and truly beautiful in the entire diocese.

Being aware of the necessity for total involvement for all people of all ages of the parish, Father Krieg was directly and indirectly responsible through approval, of the Blessed Sacrament Blue Knights, Drum and Bugle Corp., Teen Club, The In-Between Club and Sports Program.

In 1972 the Cypress Hills-Fulton Street Senior Citizens Center was established and through his hard work and tireless efforts he made a dream come true. A formal dedication of the center took place on June 22, 1973. His Excellency, Bishop Mugavero and numerous members of the clergy, as well as Mayor Lindsay and other noted dignitaries were present.

His Excellency, Bishop Mugavero, while seated at the dedication ceremonies, was free to observe the senior citizens present. He was so impressed by their love for Father Krieg, as was evident in their expressions that he was motivated to send a personal letter to Father Krieg, commending him for his work. That letter reads as follows:

Dear Father Krieg,

May I offer my sincerest congratulations and gratitude on the accomplishment of the Senior Citizens Center. I am really proud of your great leadership in bringing the very important entity to a reality.
